1. What is the problem or issue?  
Currently Sec. 19-9-102 and 19-9-207 allow two separate and distinct retirement systems to exist for local police departments. The first system (PERS) applies to cities, other than first and second class, that want to adopt it. The second system (MPORS) applies to first- and second-class cities and those other cities wishing to adopt it.
2. What do you want the legislation to do?  
The Association wants the legislation to be modified so that all cities are required to use the MPORS retirement system regardless of their "Class Designation".
3. If possible, please list the MCA (Montana Code Annotated) sections that would need to be amended.  
Sections 19-9-102 and Sections 19-9-207.
4. Which retirement plan or plans would be covered by the legislation? (If the proposal is limited to certain plans, please indicate why.)  
Chapter 9 applies to police officers only. Note the following section of law: **19-9-103. Municipal police officers' retirement system established.** There is a retirement plan known as the municipal police officers' retirement system. The plan is governed by the provisions of chapter 2 and this chapter.

If necessary for funding the contributions of both the employer and employee would need to be increased.
